

AFTER SCHOOL TRANSPORTATION TO THE PURCHASE COMMUNITY HOUSE (PCH)



Dear Parent,

Bus transportation is available after school for students from the Purchase Elementary School to the Purchase Community House for a fee. For the 2016-2017 school year, the Purchase Community House will be managing the transportation including registration, daily attendance and fees. J&R Tours will provide the 24 passenger mini-bus for the approximately 145 days the PCH is open.

Registration is on first come, first serve basis. The price for this service is a onetime fee, regardless of how many days your child will be attending the PCH and utilizing the bus service. The fee for the entire year is \$390 per student. If you wish to sign up for a single trimester (Fall, Winter or Spring) the fee is \$150 per trimester. Forms and payments should be returned to the Purchase Community House.

- Annual Fee: September 14, 2016 to May 26, 2017 \$390 per student
- Fall Only Fee: September 14, 2016 to December 23, 2016 \$150 per student
- Winter Only Fee: January 3, 2017 to March 24, 2017 \$150 per student
- Spring Only Fee March 20, 2017 to May 26, 2017 \$150 per student

Each afternoon the PCH is open, Purchase School Staff and the designated bus driver will have a list of the children riding the bus that day. The children will be escorted to the bus at dismissal. If there is a change in your child's schedule you **MUST CONTACT THE PCH BY 12:00 NOON DAILY!** Please call 949-2636 so that the school and driver are aware.

Please complete the information below and have the form **NOTARIZED**. The Superintendent of Harrison Schools requires that any student interested in this service must have a parent sign and **NOTARIZE** the attached Indemnification/Hold Harmless Clause for the school district. Both of these documents must be signed and returned to the Purchase Community House before your child can board the bus. **BOTH PAGES MUST BE NOTARIZED.**
