

TO: PURCHASE SCHOOL PARENTS
RE: AFTER SCHOOL TRANSPORTATION – PURCHASE COMMUNITY HOUSE (PCH)

Once again, J&R Tours is offering a 24 passenger mini-bus, to transport children after school to the PCH. The PCH runs programs approximately 153 days during the school year, and there will be a per child annual fee. The start date will be **WEDNESDAY, SEPTEMBER 14, 2011.**

Registration is on first come, first serve basis. Each afternoon that the PCH is open, the children would be grouped and chaperoned to the PCH bus. Both Mr. Kalman and the designated bus driver will have a list of the children.

Superintendent of Schools, Mr. Lou Wool advised that any student interested in this service must sign and **NOTARIZE** the attached Indemnification/Hold Harmless Clause for the school district. This document must be signed and sent to Mr. Kalman before your child can board the bus. **BOTH PAGES MUST BE NOTARIZED.**

The price for this service is a one time annual fee, regardless of how many days your child will be attending the PCH and utilizing the bus service. A payment of **\$410.00 per child** is required for this service. All checks must be made out to J&R Tours.

If interested, please fill out the information below, have it notarized, tear off and send the form and your payment in a sealed envelope, clearly labeled **PCH Transportation- Gina DiDonato** and kindly return it to your child's teacher.

If there is a change in your child's schedule Gina DiDonato **MUST BE CONTACTED THE NIGHT BEFORE** so that the driver is aware of the change.
